

President's Message

CONFIDENTIAL ENQUIRIES INTO MATERNAL DEATHS (CEMD)





There has been a marked reduction in the number of maternal deaths globally, thanks to the improvement of maternity care services at all levels across most countries. Despite notable progress, most low- and middle-income countries still need robust mechanisms to further reduce preventable maternal deaths and achieve the Sustainable Development Goals (SDG) Target 3.1.

Maternal Death Surveillance and Response (MDSR) is a comprehensive and effective system implemented in many countries to generate powerful evidence and implement systematic changes in policy and practice. Every maternal death provides valuable information to identify lapses and deficiencies and learn lessons

towards improving services. It is important to scale up the MDSR system to the next level to generate information that may not be available through formal inquiry process to design appropriate system wide actions to prevent them.

Confidential Enquiries into Maternal Deaths (CEMD) is considered the gold standard in the MDSR system and was initiated as far back as 1952 in the UK. CEMD includes surveillance and collecting confidential and annonymised information from those who provided care, and reviewing conducting a confidential review of such information by a group of National Expert Committee who would provide national-level recommendations.

In countries with very low maternal deaths, a combination of CEMD and Near Misses Inquiry has been used in combination as a platform to gain deeper insight into quality-of-maternity care and address care gaps and systemic barriers.

In Sri Lanka, maternal death investigations and mandatory notification of maternal deaths began in 1989. Since 1948, there has been a gradual decline in the Maternal Mortality Ratio (MMR) due to the expansion of maternity services. The MMR has remained static over the past decade in spite of the MDSR being effective islandwide and covering all field and institutional deaths. It is prudent to revisit the maternal death surveillance system in Sri Lanka and scale up the process to establish a CEMD island wide to generate quality information and sound recommendations.

Most maternal deaths are preventable. Preventable deaths are more likely to be identified when cases are analyzed by an independent group in a confidential manner. However, the auditing process is often flawed due to human and organizational biases and barriers. Confidential Enquiry strengthens the "no-blame, no shame" culture, which can be guaranteed through annonymisation of data, including names of patients, providers or hospitals, done prior to the point of analysis.

Initially, CEMD was piloted in Western and Southern Provinces in 2022, was expanded to include maternal deaths from the Central Province by 2024, and is operational island wide this year. SLCOG is firmly committed to ensuring the success of the CEMD process and contributed a full-time Pre-Intern doctor throughout the year to assist the

FHB and facilitate documentation. In addition, SLCOG successfully organized a training program for the nominated Expert Panel consisting of consultants from relevant professional organizations at the Galadari Hotel on the CEMD process.

I sincerely thank Dr. Luxman Senanayake and Dr. Ananda Ranatunga, Past Presidents of SLCOG, who volunteered to provide their technical assistance for the CEMD process that is being conducted at the FHB. SLCOG is pleased to inform you that the Ministry of

Health and the FHB have agreed to implement CEMD island-wide starting from 2025. Last year, Dr. P.G. Maheepala, former Secretary to the Ministry of Health, presented a Cabinet Paper to establish the Maternal Death Directorate to launch the CEMD process in Sri Lanka. Additionally, UNFPA has come forward to support this initiative.



Stage 1	MMR > 1000	High fertility Predominance of direct causes of maternal death with high rate of communicable diseases.
Stage 2	MMR 300-999	Similar to stage 1 But greater proportion of woman seeking health care.
Stage 3	MMR 50-299	Fertility is variable and direct causes of mortality still predominate. More woman start reaching health facilities.
Stage 4	MMR < 50	Low fertility Important to address quality of care issues and eliminate delays within health system
Stage 5	MMR < 5	Fertility very low Avoidable deaths are averted

How CEMD Works - In a Nutshell:

Notification: Inform the MDSR Unit of FHB/ proposed Secretariat of maternal deaths within 24 hours of the death of a pregnant woman. This is the responsibility of the Head of the Institution, and the obstetrician could promote timely notification.

All clinicians and other health staff who took part in the care of the deceased mother are expected to complete the Confidential CEMD formats individually within 5 days of the maternal death. The Head of the institution/ Focal point appointed for CEMD is expected to download and hand over the blank formats to the relevant officers. These formats, designed for each category of staff, are to be filled out without any identification, such as the name (names of individuals should not be included). Each report should be enclosed in a sealed envelope and handed over to the Head of the Institution.

The Head of the Institution will collect the documents from all relevant staff and send them to the MDSR unit of FHB, where sealed envelopes will be opened by a committee and filed without any names of the patient, staff, or institution to be presented to the Expert Committee. This is to be done within 14 days of the death.

Head of the Institution will send separately a copy of the BHT, JMO report, and other relevant documents in a sealed envelope within 14 days of the maternal death to the MDSR Unit of FHB/ proposed Secretariat on maternal deaths, where all these documents would be annonymised and presented to the Expert Committee without any identifiable information.

A senior-level team from the MDSR Unit of FHB/ proposed Secretariat on maternal deaths will annonymise all documents (remove all names of individuals and hospitals) to prevent identification.

Two retired senior consultants to be appointed as Chief Investigators at the proposed Directorate will review all annonymised documents and prepare a Case summary to assist the Expert Committee in their review.

- An Expert Panel, consisting of Experts nominated by the professional colleges, will be required by the MDSR Unit of FHB/ proposed Secretariat on maternal deaths to analyze the annonymised documents.
- The Expert Panel will identify the lapses, if any, barriers to care and make national-level recommendations with the "lessons learnt" at the individual case level based on all available evidence.
- MDSR Unit of FHB/ proposed Secretariat on maternal deaths, with the assistance of the Chief Investigators, will prepare an annual report on Maternal Deaths, outlining recommendations national level to be implemented with the responsible agencies identified at the next year.

- Institutional Inquiry into a maternal death will be conducted at the institution with the participation of relevant staff on site in the same way as it has been conducted in the past. This component will identify the issues related to care provided at the institutional level and make recommendations to be implemented at the institutional or higher level. The annonymised information will be provided to the Expert Committee.
- Field Investigation too will be conducted as it is being done now, independently within 14 days of the maternal death, and the reports will be sent to the MDSR Unit of FHB/ proposed Secretariat on maternal deaths as supporting documents. The annonymised information will be provided to the Expert Committee.

SAFE MOTHERHOOD PROGRAMME - NO.02 2025 District General Hospital, Vavuniya

The second Safe Motherhood Programme for the year 2025 was successfully concluded at the District General Hospital, Vavuniya, on May 16th, 2025. Capacity building of health professionals, doctors, institutional nurses, and field staff was done.





The programme was designed and launched under the leadership of Dr Sanath P Akmeemana, President of SLCOG, with the tremendous support of Dr Darshana Abeygunawardana, Chairman-Regional Activities & Developments and Dr A Sritharan, Chairman-Scientific Activities & Research. Dr Saliya Kularathne and Dr Gamini Wijewardhana coordinated the programme on behalf of the SLCOG. Young Gynaecologist Diary

"Empowering Women Facing Gynecologic Cancer: My Journey as a Gynecological Oncologist"

Becoming a gynaecological oncologist was not something I had initially dreamed of. During my internship, I was drawn to obstetrics and gynaecology, inspired by the challenging yet rewarding nature of obstetrics. However, as I prepared for postgraduate studies, I witnessed firsthand the devastating impact of malignancy within my own family. This experience reshaped my perspective.

A pivotal moment came during a three-month oncology appointment at Maharagama under the guidance of Dr. Chintana Hapuachchige. Until that visit, all I had heard about Maharagama was the haunting phrase: "Only footsteps enter, but none return." But reality proved different—I saw how a team of dedicated professionals transformed the fate of women who, in their minds, were carrying death certificates. Their unwavering commitment left me in awe. A thought lingered in the back of my mind: If I could contribute to this, I would. Yet doubts crept in—was I capable of performing such intricate surgeries? Was I a gifted surgeon? Would I falter halfway? I did not know.

I successfully passed the MD Part 2 at the top of my cohort. Then came the moment of decision. Obstetrics had drawn me into the field, yet pursuing gynecologic oncology would mean leaving obstetrics behind. After much contemplation, I made my choice—I would dedicate myself to gynecologic oncology.

At National Cancer Institute - Maharagama, I was fortunate to train under exceptional consultants who guided me through every possibility and stood by me until I gained full confidence. Mistakes were met with learning opportunities rather than blame, fostering an environment of growth. My overseas training took me to one of the most advanced regional referral centres in the UK, where I was exposed to an array of complex procedures, including laparoscopy, vulval reconstruction, ultra-radical multi-visceral laparotomies, and advanced robotic surgeries. I had the privilege of learning from some of the most esteemed figures in gynecologic oncology, just before their retirement—a priceless experience.



Upon returning, I began working at the National Hospital in Kandy. The role of a gynaecological oncologist within a national hospital is both demanding and deeply fulfilling. Navigating challenges—ranging from resource limitations to logistical constraints—requires continuous adaptation and strategic enhancements to the healthcare system.

Despite its status as a national hospital, resource limitations remained a stark reality. Transitioning from a high-tech setting in the UK to a



resource-constrained environment felt like landing straight from the sky. There, patients benefited from comprehensive imaging and multidisciplinary decision-making, with shared responsibilities. Here, the landscape was entirely different—MRI and CT scans were not readily available, securing an ICU bed was a challenge, and many patients had undergone unsuccessful surgeries with little clarity on the next course of action.

Fortunately, the unit had already been developed over time thanks to my two senior colleagues. With a

constant influx of referrals, the surgical team had to strike a balance between efficiency and quality care. A well-established standard was in place, and regardless of my seniority, I had to integrate seamlessly into this fast-moving system. Before beginning work, I carefully mapped out my approach, holding discussions with administrators, anaesthetic colleagues, and my team. Despite the challenges of limited resources, the unwavering support of my consultant colleagues, junior doctors, and the dedicated staff in the ward, theatre, and clinic has been a tremendous relief.

As a major referral hub for gynecologic oncology, the National Hospital Kandy faces a consistently high patient volume, necessitating streamlined processes to manage caseloads effectively. I worked to expand operating theatre lists, ensuring a smoother workflow with my team of three doctors, nurses, and minor staff working tirelessly. I introduced protocols for admissions, prioritised the surgical waitlist, and implemented structured operative record-keeping. Enhanced recovery was a priority.

Thanks to the support of my senior colleagues at referral hospitals, I travelled and performed surgeries at their locations, significantly reducing patients' travel expenses, minimising wait times, and freeing surgical slots for others in need. Within two months, I had successfully reduced the waitlist to just 1-2 weeks from the initial referral. Hospital stays became shorter, optimising patient care.

Beyond clinical work, I actively engaged in research, academic activities and public education through health camps, academic sessions, and social media advocacy. I supported post-graduate trainees in discussing oncology cases and guided them through surgical procedures.

For those considering this path, the journey is undoubtedly demanding, but the impact you can make is profound. When we do our job well, we provide hope to individuals who need it most, and that sense of purpose is truly fulfilling. Money is not the driving force—we work with patients battling life-threatening conditions, and knowing that we have helped prolong their lives and improve their quality of life is what matters most.

I take this opportunity to express my heartfelt gratitude to all my trainers, my parents and family, my team, and SLCOG for their unwavering support throughout this journey.


